2. The Society registration shall be liable to cancellation, in case, it has been obtained by misrepresentation/fraudulently/false documentation. This shall also attract punitive action under relevant provisions of law.
3. This certificate of registration does not construed any statutory permission/ license to the Society to undertake aims & Objectives as specified in the byelaws/ constitution filed in this office, which, however, shall be subject to the production of NOC(s)/ License(s), required if any, under any other law/statute of the Government (Centre/ UT).
4. The document certifies registration under the Society Registration Act 1860 only. However, any Govt. Deptt/Any other association/person(s) etc may make necessary verification (on their own) regarding the conduct, assets & liabilities etc of the society before entering in to any contract/ assignment with the instant society.
5. The society shall not be entitled to use it's translated/ abbreviated/ acronym name and shall use the registered name only clearly indicating that It is governed by private body/ society and not by the Government.
6. Further, the society shall not be used for any commercial or trade or business purposes or profession, certification/ affiliation/recognition to other organizations.
7. Under no circumstances shall the Society change its registered name, members, location of the society, constitution/ rules etc except with the prior approval/ permission of the Registrar of Societies.
